- That on the day of 1/12/ 2025 this agreement was drawn up between each of the following:
- The first party: Messrs. Alesayi & AlSawadi Group co -Dreamnet,represented by Mr. Ali Hussein Al-Sawadi . General Manager
- The second party: Messrs. Philippine Consulate General in Jeddahrepresented by Mr. Alfred Kristoffer A. Guiang Consul and Acting Head
- It has been agreed between the two parties on the following:
- The first party supplies internet service and Wifi system for the second party as following:
 - Internet speed 20MB BBI on Fiber for a year (twelve Months)
 - Wi-Fi Service solution
 - Internet technical support during office hours
 - Internet support during off hours will be done at the earliest ASAP5- Wi-Fi 12 Months technical and support is Free
- The total value is an amount of 63,600 (SAR only) without VAT
- The total value including invoice no 240095 date 01-01-2025 with VAT 15% is 73,140 (SAR only)
- The term of the contract is one year, and the second party may not cancel it during thecontract period
- Internet service Starting from 1 JAN 2025 till 31 DEC 2025
- The second party pays the first party 100 % in Advance when signing the contract
- The first party installs and operates the second party within week after receiving 100 % ofthe contract value.
- The second party shall cooperate and supply the requirements and information necessary forthe first party to operate and install the service.
- The first party is not responsible for the second party's internal network.
- The contract is automatically renewed unless notified by one of the parties 60 days beforethe end of the contract
