INVITATION TO BID FOR THE SECURITY SERVICES OF THE PHILIPPINE CONSULATE  
GENERAL IN JEDDAH

1. The *Philippine Consulate General in Jeddah*, through the *General Appropriations Act*, intends to apply the sum of USD 115,200.00 or SR 432,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for the *Security Services of the Consulate General*. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2. The *Consulate General* now invites bids for the following:

2	Security guard/watchmen for night shift and during weekends and holidays	2
3	Security equipment such as metal detectors, security barriers and communication equipment	As necessary

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided under the IRR of RA 9184.

5. Interested bidders may obtain further information from the Consulate General and inspect the Bidding Documents at the address given below during office hours from 9:00 a.m. to 5 p.m.

**A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Hundred riyals (SR500.00).**


It may also be downloaded free of charge from the websites of the Consulate and the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The Consulate General will hold a Pre-Bid Conference on **21 February 2019** at 2:00 pm at the **PCG Conference room, 2<sup>nd</sup> floor, Philippine Consulate General , Bldg. no.2, Philippine Consulate General, Bldg.No. 4663, Fajer St. Al Rehab District 6, Jeddah, K.S.A.**, which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before **12:00 noon of 03 March 2019**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Section 27.2 of the IRR of RA 9184.

Bid opening shall be on **03 March 2019** at the **PCG Conference room, 2<sup>nd</sup> floor, Philippine Consulate General , Bldg. no.2, Philippine Consulate General, Bldg.No. 4663, Fajer St. Al Rehab District 6, Jeddah, K.S.A.**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Consulate General* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
